Cancer Foundation of Saskatchewan Charity Charger Car Raffle

OFFICIAL RULES: By participating, entrants agree to be bound by these Official Rules and by the decisions of the **Cancer Foundation of Saskatchewan**, which shall be binding and final as to all matters related to the Raffle. The Raffle is operated under Provincial **Lottery Licence # LR22-0140** and is subject to all applicable federal, provincial and local laws.

NET PROCEEDS: All net proceeds of the Raffle will benefit the **Cancer Foundation of Saskatchewan** (hereafter known as "Sponsor") and the programs that Sponsor supports.

GRAND PRIZE - 1970 Dodge Charger RT Resto Mod, with an appraised value of \$185,000. There is no cash option. No additional costs included.

50/50 JACKPOT – 50% of the gross 50/50 Raffle ticket sales with a maximum of \$500,000 in sales and a maximum prize of \$250,000.

ELIGIBILITY TO ENTER: During the dates and times and other details specified below, raffle tickets are available for purchase online at <u>cancerfoundationsask.ca/charitycharger</u>. Tickets may only be purchased or sold in Saskatchewan. Employees or Board Members of the Cancer Foundation of Saskatchewan, people involved in the conduct and management of the raffle, their spouses and any person residing in the same household, are NOT allowed to purchase tickets. Only people 19+ are eligible to win.

PURCHASING RAFFLE ENTRIES: The following prices and corresponding "ticket numbers" are available for purchase for the car Raffle: **1 ticket for \$50, 3 tickets for \$100 and 10 tickets for \$250.** Sales will begin April 7th, 2023 and end at 2:00 pm August 20th, 2023 with the draw made shortly after 2:00pm.

Grand prize ticket purchasers are eligible to add on 50/50 Jackpot tickets. 50/50 tickets can ONLY be purchased at the time of grand prize ticket purchase.

50/50 Jackpot: 1 ticket for \$10, 10 tickets for \$20, 50 tickets for \$50 and 200 tickets for \$100.

NUMBER OF RAFFLE TICKETS:

Car Raffle: A maximum 88,800 tickets available to be sold. The maximum value of ticket sales is \$2,200,000

50/50 Jackpot: A maximum of 1,000,000 tickets available to be sold. The maximum value of tickets sales is \$500,000

THE DRAWS: Both draws will be: August 20, 2023 @ 2:00PM, Rock 102's Show & Shine Downtown Classic Car Show, 1st Ave & 22nd St, Downtown, Saskatoon, SK. The winner does not need to be present at the draw and will be contacted by phone per the information they submitted at time of purchase. The winning number will be announced at the event, on social media and posted to the Cancer Foundation of Saskatchewan's website.

Prizes will be awarded to the name on the ticket. If more than one name is on a ticket, the Sponsor will only issue the prize to the individual listed first on the tickets. The Sponsor or SLGA are not responsible for any disputes.

The winning ticket is drawn electronically by random number generator approved by SLGA. The winner will have 365 calendar days from the draw date to claim their prize. If the prize goes unclaimed beyond their hold date, the prize shall be donated to a charitable beneficiary approved by SLGA in accordance with Section 13(d) of the SLGA's Terms and Conditions.

DETERMINATION OF OFFICIAL WINNER(S): Sponsor shall have the sole discretion to determine whether each Potential Winner is an official winner of a Prize (an "Official Winner"). Sponsor's decision concerning the identity of all Official Winners shall be final and binding. The Cancer Foundation of Saskatchewan is not responsible for any licensing, registration or insurance of the prize. Transfer of ownership will be made to the winner. Winner assumes all responsibilities of owning the vehicle, including but not limited to registration, insurance, maintenance and repairs, at the time of transfer of ownership. A check will be mailed to the winner of the 50/50 Jackpot within 2 weeks of claiming prize.

tampering, hacking, or by viruses, worms, or malfunctions affecting a network, server ISP or any equipment or programming used in or associated with the Raffle; (4) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (4), "Errors"), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying Potential Winners, determining Official Winners, or announcing or delivering Prizes; or If any portion of the Raffle is compromised, in Sponsor's sole judgment, by a virus, worm, bug, non-authorized human intervention or other causes which, in Sponsor's sole judgment, corrupt or impair the administration, security, fairness or proper play of the Raffle, or the proper submission or capture of Entries (collectively, a "Compromising Event"), then Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Raffle, and to select winners from all eligible, non-suspect Entries received before the known occurrence or discovery of such Comprising Event. All Entry purchases shall be final, and no refunds or replacements will be issued by Sponsor. Sponsor has sole and final decision on admissibility of entries and the determination of prize winner.
